Is Alevo a new energy storage company?

This article is more than 8 years old. In late 2014,a virtually unknown company called Alevo announced it was entering the energy storage marketwith a new inorganic, sulfur-based lithium ion battery technology that it had acquired from the bankrupt German company fortu PowerCell.

#### Is Alevo a good company?

Alevo had some successes. Earlier this year, it signed an agreement with Ormat Technologies to jointly build, own and operate the 10 MW Rabbit Hill Energy Storage Project in Georgetown, Texas. And last year, the company began a project to build an 8 MW, 4 MWh energy storage system in Lewes, Dela., that uses Alevo's GridBank technology.

#### What does Alevo do?
