

# Bahamas energy storage subsidy public notice list

How does a comprehensive energy policy work in the Bahamas?

Our comprehensive energy policies work together to modernize our system and bring electricity prices down in The Bahamas. 70MW of solar power and 35MW of Battery Energy Storage Systems will be integrated into the existing grid.

How will a new energy system affect the Bahamas?

Comprehensive upgrades to our country's transmission and distribution infrastructure, and switching from heavy and diesel fuels to solar power and natural gas, will create new efficiencies and reduce the price of electricity in The Bahamas. But it won't happen overnight - it will take time to upgrade our grid and to integrate cleaner energy.

Will the Bahamas build utility-scale solar power?

For the first time, The Bahamas is on the path to building utility-scale solar power across our islands. Large photovoltaic (PV) solar arrays will capture the energy from the sun and send it to our country's electricity grid. What steps are required as The Bahamas moves forward with utility-scale solar power, and what are the costs?

Will the Bahamas have a 30 per cent renewable power generation?

This also encompasses the Government's goal of The Bahamas having a 30 per cent renewable power generation by the year 2030. The Minister explained that microgrids will ensure consistent and reliable power output for island inhabitants, addressing unique island requirements.

What is a solar energy microgrid in the Bahamas?

This initiative involves developing solar energy microgrids across the Family Islands. This also encompasses the Government's goal of The Bahamas having a 30 per cent renewable power generation by the year 2030.

Is the Bahamas ready for a sustainable future?

The Prime Minister said the choice The Bahamas faces is stark. "Continue down a path of expensive, unreliable energy or pivot towards a future where energy is sustainable, affordable and secure." He noted that this Government administration's number one focus is reducing the cost of living for every Bahamian.
