How much money will Ballard invest in Phase 1?

In Phase I,Ballard plans to invest approximately \$110 million(net of the \$40 million in expected DOE grants and the \$54 million in expected 48C tax credits) from 2024 through the end of 2027 to build and commission a new manufacturing facility for membrane electrode assemblies (MEAs), bipolar plates, stacks, and engines.

How much money did Ballard receive for Rockwall Gigafactory?
