

What do we expect in the energy storage industry this year?

This report highlights the most noteworthy developments we expect in the energy storage industry this year.

Prices: Both lithium-ion battery pack and energy storage system prices are expected to fall again in 2024.

How big is the energy storage industry in 2022?

The U.S. held industry share of over 13% of the global energy storage systems market in 2022. Regulatory bodies have been crucial in driving investments in the energy and electric infrastructure and have continued to invest in the development, demonstration, and research of energy storage technologies.

What is the growth rate of industrial energy storage?

The majority of the growth is due to forklifts (8% CAGR). UPS and data centers show moderate growth (4% CAGR) and telecom backup battery demand shows the lowest growth level (2% CAGR) through 2030. Figure 8. Projected global industrial energy storage deployments by application

What is the future of energy storage?

Renewable penetration and state policies supporting energy storage growth Grid-scale storage continues to dominate the US market, with ERCOT and CAISO making up nearly half of all grid-scale installations over the next five years.

Which long-duration energy storage technologies have a critical year ahead?

Beyond lithium-ion batteries, other long-duration energy storage (LDES) technologies have a critical year ahead. China has forged ahead with its LDES development and will remain the frontrunner this year, even as US, UK, Australia and other markets support LDES growth.

Which energy storage technology is most widely used in 2022?

Mechanical technologies, particularly pumped hydropower, have historically been the most widely used large-scale energy storage. In 2022, global pumped storage hydropower capacity surpassed 135 gigawatts, with China, Japan, and the United States combined accounting for almost one third of this value.

The bidding volume of energy storage systems (including energy storage batteries and battery systems) was 33.8GWh, and the average bid price of two-hour energy storage systems (excluding users) was \$1.33/Wh, which was 14% lower than the average price level of last year and 25% lower than that of January this year.

Energy storage systems (ESS) in the U.S. was 27.57 GW in 2022 and is expected to reach 67.01 GW by 2030. The market is estimated to grow at a CAGR of 12.4% over the forecast period. The size of the energy storage industry in the U.S. will be driven by rising electrical applications and the adoption of rigorous energy efficiency standards.

The top five companies accounted for 24% of patenting activity. Analysis of patenting activity by companies shows that Contemporary Amperex Technology filed the most energy storage patents within the power industry in Q3 2024. The company filed 108 energy storage-related patents in the quarter, compared with 210 in the previous quarter.

This subsegment will mostly use energy storage systems to help with peak shaving, integration with on-site renewables, self-consumption optimization, backup applications, and the provision of grid services. We believe BESS has the potential to reduce energy costs in these areas by up to 80 percent.

The company is working on a large-scale 220 MW Battery Energy Storage System project in North Rhine-Westphalia and is likely to be commissioned in 2024. The battery energy storage systems industry has witnessed a higher inflow of investments in the last few years and is expected to continue this trend in the future.

Further, in 2021, China announced its plan to boost cumulatively installed non-pumped hydro energy storage to around 30 GW by 2025 and 100 GW by 2030, which, coupled with recent adoptions of time-of-use power tariffs that create a greater range between peak and off-peak power prices, are driving a boom in battery storage activity.

Europe and China are leading the installation of new pumped storage capacity - fuelled by the motion of water. Batteries are now being built at grid-scale in countries including the US, Australia and Germany. Thermal energy storage is predicted to triple in size by 2030. Mechanical energy storage harnesses motion or gravity to store electricity.
