Normally a solar system of this size would cost around \$16,740 in Hawaii. Thanks to the 30% federal tax credit and the Hawaii income tax credit (\$5,000), the net system cost is reduced to only \$6,718.

The following Residential Clean Energy Tax Credit amounts apply for the prescribed periods: 30% for property placed in service after December 31, 2016, and before January 1, 2020 26% for property placed in service after December 31, 2019, and before January 1, 2022

## Hawaii energy storage tax credit

Hawaii legislation effective Sept. 15 provides that for taxable years beginning Jan. 1, 2020, no renewable energy technologies tax credit can be claimed for a solar energy system that is 5 megawatts or larger in total output capacity and requires a power purchase agreement (PPA) approved by the public utilities commission (PUC).
