Is Idaho Power proposing new net metering rules?

Idaho Power published a customer-sited generation study on June 30, advancing the regulatory process to propose new net metering rules.

Will Idaho switch to a net-billing system?

The Idaho Public Utilities Commission (PUC) approved on Dec. 29,2023,a shift to a net-billing system instead of compensation based on a kilowatt-hour-for-kilowatt-hour basis for solar system owners.

Is Idaho Power undervaluing rooftop solar?

The Idaho Public Service Commission (PSC) has amended an earlier ruling from its December 2019 decision to deny Idaho Power"s net metering replacement rates, deeming that the "grandfathered" net-metering rate given to a system installed before the date of that decision is applied to the installation and not the customer.
