### New jersey energy storage rebates

Does New Jersey natural gas offer rebates?

New Jersey Natural Gas (NJNG) offers a variety of rebatesto residential customers who are making energy efficient home upgrades through the SaveGreen Project. They also participate in the statewide New Jersey Home Performance Program and offer up to \$1,500 in incentives for energy efficient HVAC equipment.

Does New Jersey offer rebates for energy efficient home appliances?

New Jersey's Office of Clean Energy (OCE) offers rebates to state residents who purchase energy efficient home appliances that are eligible. The program website has a search engine where consumers can look up if their product is eligible for a rebate.

What rebates are available in New Jersey?

Rebates may be available through New Jersey's Clean Energy Program(TM) (NJCEP)and,for customers of New Jersey Natural Gas,The SAVEGREEN Project® (SAVEGREEN)can help with the purchase and installation of eligible high-efficiency central air conditioning systems,natural gas furnaces,boilers,and water heaters.

Does New Jersey have a solar rebate program?

The SuSI program technically provides lower savings than both of New Jersey's previous solar rebate programs: the Transition Incentive program and the NJ SREC program. The following table outlines how much a 6 kW system in New Jersey would earn annually under each of the programs:

When will Energy Star rebates be available in New Jersey?

Rebates for purchases of ENERGY STAR® certified appliances made on or after July 1,2021in New Jersey will be available. Customers who purchased appliances before July 1,2021,should apply to New Jersey's Clean Energy Program at www.njcleanergy.com.

What is the energy storage rebate program?

The program was started in 2018,as a response to the need for energy storage systems in fire-prone areas where utility companies frequently shut off power. The program currently offers rebates of between \$150 and \$1,000 per kilowatt-hour storage.
