Is it possible to get free solar panels in Ohio?

You cannot get free solar panels in Ohio. However, if upfront costs are still out of your budget after considering incentives, you might consider leasing solar panels. Leasing is less expensive than purchasing, but it does not offer the same tax and net metering benefits.

What is the cost to install solar panels in Ohio?

The cost to install solar panels in Ohio ranges from around \$15,000 to \$25,000. The costs depend on the size of the home and the installation procedures. Any financial incentives applied to the project will impact the total cost as well.

Can you get a loan for solar panels in Ohio?

The Ohio state government offers a reduced-interest loan for energy-efficient home upgrades (including solar panels) called ECO-Link. If you work with a participating contractor and are approved by a participating financial institution, you'll be able to finance solar panels at a reduced interest rate--3% below the market rate.

Do I need a permit to install solar panels in Ohio?

A building and electrical permit is required to install solar panels in Ohio. The fee attached to these permits will vary according to your ZIP code. Call your local zoning department to inquire if a zoning permit is required and learn more about the required permits.

How long do solar panels last in Ohio?

High-quality solar panels have a lifetime of 25 to 30 years. However, with Ohio's rates, your system will pay for itself in less than half of that time. Solar panels in Ohio typically last for a long time before they need to be replaced.

A typical rooftop solar panel system might generate something like 6 to 12 SRECs per year, so even in a best-case scenario, you're only looking at \$60 in cash incentives annually.
