What is the Oregon Solar Rebate program?

The Oregon Department of Energy's program is designed to expand access to renewable solar to Oregonians with lower incomes. If your household is considered low- or moderate-income, you could receive a rebate worth up to 60 percent of the cost of your system.

Does Oregon have a Home Energy Rebate program?

Funding for these programs comes to Oregon thanks to the 2022 Inflation Reduction Act (IRA). ODOE submitted our initial application for the home energy rebates to the U.S. DOE in March 2024.

How do I get a solar rebate?

Rebates are paid to the ODOE-approved contractor who installs the system, so please start by reaching out to an approved contractor to talk about your project. Contractors will also be able to help identify other potential solar savings, such as a federal tax credit or an Energy Trust of Oregon incentive.

Who is eligible for a solar rebate?

Rebates are issued to approved contractors, who pass the savings on to customers. The contractor must submit a reservation application before starting construction or installation of a solar system or paired solar and storage system in order to be eligible for a rebate.

How do I get a rebate from odoe?

ODOE has developed an online user guide for contractors to use the PowerClerk system. Please contact the Solar + Storage Rebate Team if you have questions. How Do I Receive a Rebate Payment? We work with the Department of Administrative Services to send out contractor rebates. The payment process typically takes two weeks.

The Oregon Department of Energy offers a new battery rebate that applies to both standalone solar energy storage systems as well as systems that incorporate backup batteries. This rebate covers up to 60% of the net cost of installing your new solar energy system, up to \$5,000 for standalone solar energy systems and up to \$7,500 for systems that include batteries.
