Why is electricity supply a challenge in Paramaribo?

Electricity supply in the sparsely inhabited interior is a challenge because of geographic remoteness. Fuel transport to these remote villages is done by boat, while communities closer to Paramaribo can usually be reached by road. Since most of these communities are quite remote, there is a challenge to supply electricity in a cost-efficient way.
