Also known as the Investment Tax Credit or Residential Clean Energy Credit, this federal incentive allows homeowners to get a tax credit for 30% of the cost of their fully installed solar panel system.

Your entire system qualifies for this incentive, including the equipment, labor, permitting, and sales tax. The average cost for a 5 kW solar panel system in New York is around \$15,205.

Homeowners living in Con Edison's territory can receive an incentive rate of \$0.20 per watt of solar installed, which works out to \$1,400 for a 7 kW solar system.

The price of solar panels in New York averages around \$3.07 per watt, but New York Solar Incentives, tax credits, and rebates can make solar energy systems more affordable. These financial incentives can significantly offset the upfront costs ( 10 ).
