Who is Solid Energy New Zealand?

Is Solid Energy a state owned company?

Solid Energy was the largest coal mining company in New Zealand and is a state owned enterprise of the New Zealand Government. The company was formed from the former government department State Coal Mines.

Who is Solid Energy?

It was formed in 1987 from the former Government department State Coal Mines. The company's annual production was approximately 4 million tonnes, of which about 70% is used in steel making. Solid Energy's main mining operations were in Waikato in the central North Island and in the West Coast/Buller region.

What happened to Coalcorp & Solid Energy New Zealand?

In 1996 Coalcorp, as it had become, was rebranded Solid Energy New Zealand Ltd. Coalcorp and Solid Energy inherited many of the liabilities and assets of State Coal Mines. As well as operating existing mines the company is responsible for the rehabilitation of a number of former mine sites across the country.

Where is Solid Energy located?

Solid Energy's main mining operations were in Waikato in the central North Island and in the West Coast/Buller region. Waikato coals are sub-bituminous, supplied predominantly to the New Zealand Steel plant at Glenbrook and Genesis Energy's Huntly Power Station.

How much money does Solid Energy make in New Zealand?

New Zealand media proffered reasons for Solid Energy's problems. The Dominion Post pointed out that, in 2004, 64 Solid Energy staff earned more than \$100,000 but by 2011 that number had increased to 368. Over the same period Don Elder's salary had increased from between \$570,000-\$580,000 to \$1.36 M.

Our Operations Solid Energy's Coal Business. Prior to it's sale to BT Mining Limited, Solid Energy extracted, processed, marketed and distributed coking, thermal and specialist coal from opencast mines around Huntly in the Waikato, and Westport on the West Coast.

Within New Zealand coal is carried from Solid Energy mine sites to our major customers for the most part by rail, with smaller volumes delivered by road. In the Waikato, coal is railed directly from our Huntly East Underground and Rotowaro Opencast Mines to New Zealand Steel's Glenbrook Mill and from Rotowaro to Genesis Energy's Huntly ...

The Rotowaro coalfield is located 10 km southwest of Huntly and supports a number of opencast mines including Solid Energy's Township and Awaroa opencast mines. Both the lower and upper Waikato coal measures are present. The lower measures are up to 200 m thick, while the upper measures reach 100 m.

The lignite resources of the Southland coal region comprise a reported 71% of New Zealand's recoverable coal resources. The various coalfields within this region are multi-seam with up to 15 minable horizons. Most of the Southland coal region basement rocks are Early to Middle Mesozoic volcanogenic greywackes and argillites.

In 2000 Grey Coal, a joint venture between Solid Energy and Todd Energy, opened an underground mine at Spring Creek, planned as a replacement for Strongman 2 which closed on August 15 2003. Development was temporarily halted in February 2001 but following Solid Energy's purchase of Todd's half share of the venture in 2002, mining ...
